GENERAL TERMS

- 1. The international tournament "Russia Open" is held to popularize and develop Hapkido in Russia and determine the level of physical fitness.
- 2. The main objectives of the International Tournament "Russia Open" are:
- promoting health and creating conditions for active physical culture and sports;
- formation of a healthy lifestyle;
- improvement of forms of organization of mass physical culture and sports work;
- promotion of Hapkido among young people;
- strengthening international relations between teams from different countries;
- popularization and development of hapkido as an international sport;
- improving the sportsmanship of athletes of the Russian Federation.
- 3. This Regulation is an official invitation and the basis for sending athletes to sports competitions.
- 4. Competitions are held in accordance with the international Rules for competitions in the sport of "Hapkido" with the number-code of the sport 1770001411A, on the basis of order N 199 of the Ministry of Sports of the Russian Federation dated March 14, 2019.

ORGANIZERS OF COMPETIONS

Organizers of the competition: Hapkido Federation of Russia.

The general management for the conduct and organization of competitions is entrusted to the All-Russian Public Physical Culture and Sports Organization Hapkido Federation of Russia under the leadership of Grand Master Demid Momot.

REFEREEING CORPS

The qualification of referees must be confirmed by the Dan certificate of an international Hapkido organization and (or) a sports referee category issued by one of the Hapkido organizations.

First of all, persons who have passed international refereeing seminars on Hapkido refereeing in accordance with the rules of the Hapkido sport approved by the Ministry of Sports of the Russian Federation, are certified for the title of "Referee" and have experience in refereeing international competitions can apply for the post of Referee.

DRAW OF PARTICIPANTS

The draw of sparring competitions is made taking into account the sowing of the athlete in accordance with its results for 2 (two) calendar years preceding the day of the competition in such a way as to eliminate as much as possible the possibility of athletes leaving the same team against each other in the first battles, except when there are not enough participants from other teams in the refereeing protocol.

The draw for the demonstration competitions is made according to the rating principle: the strongest athletes (teams) who have already won prizes at international Hapkido tournaments, as well as those with the highest technical levels, occupy positions at the end of the list of participants.

ARBITRATION

Composition of the Arbitration Commission and qualification of members:

Members of the Judging Board, holders of the 4th Dan Hapkido and above, issued by the Hapkido International Organization and recommended by the President of the RHF.

Composition: one Chairman and no more than seven members, including the Technical Delegate. Responsibilities: The Arbitration Commission shall make corrections to judicial counts, depending on their decision to appeal, and shall take disciplinary measures against officials who have committed erroneous or other unlawful acts. The results are provided to the President of the RHF. The Arbitration Commission is also entitled to deal with competition management issues.

Appeal procedure (protest):

- 1. If there is an objection to the decision of the judge, the official representative of the team must, within 10 minutes after the athlete's speech, submit an application for review of the decision (protest) to the Arbitration Commission, together with payment in the amount of 10,000 (ten thousand) rubles (120 euros), so that the decision on the result of the appeal can be announced after 30 minutes. In case of a positive protest decision, the contribution is returned.
- 2. An appeal meeting shall be held by the Arbitration Commission, with the exception of judges from the same region as the participant concerned. The decision is taken by a vote.

APPLICATIONS FOR PARTICIPATION

Applications for participation in the World Hapkido Cup are submitted electronically strictly set form, only in the form of Excel document.

Documents confirming sportsman's identity, level of his qualification, sports insurance for participation in Hapkido competitions, medical admission of doctor to competitions are attached to each application.

When completing an electronic application, participants are distributed within age groups depending on the weight category: from less weight to more.

Applications for participation are submitted to the mandate commission according to the forms established for each type of competition program.

The following documents are provided at the mandate commission:

- name application in form "A"
- agreement (original) on life and health insurance against accidents for each participant for an amount equivalent to at least 10 (Ten) thousand rubles. Insurance is carried out by participants independently;
- certificate confirming the technical qualification of the participant in Hapkido.
- identification document.
- starting fee: for foreign participants, a starting fee of 50 euros, a double of 25 euros.
- certificate from a sports doctor about admission to participate in competitions.

REWARDING

Winners of categories are awarded with cups, medals and diplomas. Prize-winners in all categories are awarded medals and diplomas.

According to the results of all types of program, the team championship is summed up and the winning team is awarded a special cup.

FINANCING

Financing is carried out at the expense of sending organizations.
