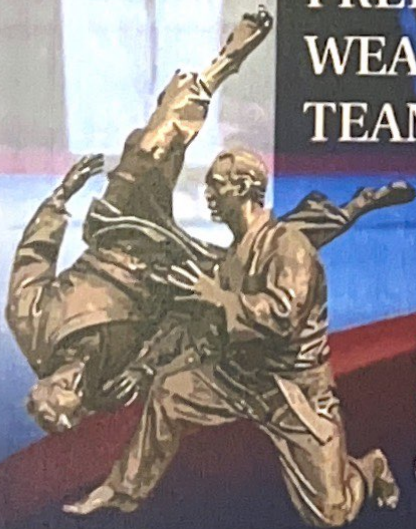

of the International Hapkido Tournament
"DEMID MOMOT CUP"

November 17, 2023

Russia, Saint Petersburg,

GENERAL PROVISIONS

1. The international Hapkido Tournament "**DEMID MOMOT CUP**" is conducted for the purpose of Hapkido popularization and development in Russia and of the determination of physical preparedness level.
2. The main objectives of the international Hapkido Tournament "**DEMID MOMOT CUP**" are:
 - to strengthen health and create conditions for physical activity and sports;
 - to maintain a healthy lifestyle;
 - to improve organization forms of mass physical culture and sports work;
 - to promote Hapkido among young people;
 - strengthen international ties between teams from different countries;
 - popularize and develop hapkido as an international sport;
 - to increase skill athletes.
 - to improve the sportsmanship of athletes of the Russian Federation.
3. This Regulation is an official invitation and this is grounds for sending athletes to sports competitions.
4. The Competitions are held in accordance with the international Rules of competition in the Hapkido sport with the sport code number 1770001411A, based on Order No. 199 of the Ministry of Sports of the Russian Federation dated March 14, 2019.

COMPETITION ORGANISERS

The organizers of the competition are:

- The World Hapkido Association
- The Russian Hapkido Federation.

Overall management of the organization and holding of the competitions is carried out by the all-Russian public sports organization «Russian Hapkido Federation», by the President Grand Master Demid Momot.

- The Chief Judge of the competition Ikromkhon Yakhyaboev, the head of the Russian Hapkido Federation panel of judges, Russia;
- Deputy Chief Judge, Gleb Pokrovskii, the international category judge in Hapkido, Russia;
- Competition Director, Evgeniy Leonov, the international category judge in Hapkido, Russia.
- Chief Secretary of the competition, Evgeniy Markov, Russia.

Competitions are held at the address: Russia, Saint Petersburg, Futbol'naya Street, 8, the «SIBUR ARENA» Concert and Sports Complex.

The participation of spectators is governed by the Regulations of the Committee on Physical Culture and Sports of St. Petersburg, as well as the resolutions of the Governor of St. Petersburg.

PARTICIPANTS OF THE COMPETITION

Representatives of any organizations are allowed to participate in the competition, who passed technical hapkido certification, regardless of style, nationality and region affiliation.

The participating team that has applied for competition includes:

1. Athletes in each weight and technical category – without restrictions;
2. Coaches – no restrictions;
3. Judges – at least one person;
4. Team representative – one person.

PANEL OF JUDGES

The qualification of judges must be confirmed by a "Dan" certificate of the international hapkido organization and/or a sports judging category issued by one of the hapkido organizations.

First, persons who have passed international or republican judicial seminars on hapkido judging in accordance with the rules of the sport of Hapkido approved by the Ministry of Sports of the Russian Federation, certified for the title of "Referee" and have experience in judging international competitions can apply for the position of Referee and Arbitrator.

DRAWING OF THE PARTICIPANTS

The draw of sparring competitions is made taking into account the athlete's seeding in accordance with his results for 2 (two) calendar years preceding the day of the competition in such a way as to exclude as much as possible the possibility of athletes from the same team against each other in the first fights, except in cases when there are not enough participants from other teams in the judging protocol.

The draw of demonstration competitions is made according to the rating principle: the strongest athletes (teams) who have already won prizes at international hapkido tournaments, as well as those with the highest technical levels, occupy positions at the end of the list of participants.

ARBITRATION

Membership of the Arbitration Commission and qualification of members:

Members of the RHF Judging Panel who possess the 4th Dan of Hapkido and higher, issued by the International Hapkido Organization and recommended by the President of the RHF.

Members: One Chairman and no more than seven members, including a Technical Delegate

Responsibilities: The Arbitration Commission makes corrections in the judges' calculations, depending on their decision regarding the filing of appeals, and takes disciplinary measures against officials who have committed erroneous or other illegal actions. The results are provided to the President of the RHF. The Arbitration Commission also has the right to resolve issues related to the management of the competition.

1. If there is an objection to the decision of the judge, the official representative of the team must apply for review of the decision (protest) to the Arbitration Commission within 10 minutes after the athlete's speech together with a payment of 10,000 (ten thousand) rubles (200 euros), so that the decision on the outcome of the appeal could be announced in 30 minutes. In case of a positive decision of the protest, the fee is refunded.

2. The meeting on the appeal is held by the Arbitration Commission, except for judges from the

3. To find out the facts, the members of the Arbitration Commission may also call interested officials of the judging in order to find out their opinion.

4. The decision made by the Arbitration Commission is final and cannot be appealed.

APPLICATIONS FOR PARTICIPATION

APPLICATIONS FOR PARTICIPATION IN THE HAPKIDO WORLD CUP ARE SUBMITTED ELECTRONICALLY STRICTLY IN THE PRESCRIBED FORM, ONLY IN THE FORM OF AN EXCEL DOCUMENT.

APPLICATIONS SUBMITTED NOT IN THE PROPER FORM ARE NOT ACCEPTED FOR CONSIDERATION BY THE CREDENTIAL COMMITTEE.

DOCUMENTS CONFIRMING THE IDENTITY OF THE ATHLETE, THE LEVEL OF HIS QUALIFICATIONS, SPORTS INSURANCE FOR PARTICIPATION IN HAPKIDO COMPETITIONS, MEDICAL ADMISSION OF A DOCTOR TO COMPETITIONS ARE ATTACHED TO EACH APPLICATION.

When filling out an electronic application, participants are distributed within age groups depending on the weight category: from a smaller weight to a larger one.

Applications for participation are submitted to the Credential Committee according to the forms established for each type of competition program.

The following documents are provided to the Credential Committee:

- a registered application in the form "A"
- an agreement (original) on life and health insurance against accidents for each participant for an amount equivalent to at least 10,000 (ten thousand) rubles. Insurance is carried out by participants independently;
- a certificate confirming the technical qualification of the participant in hapkido.
- an identity document.
- entry fee: for foreign participants, the entry fee is 50 euros, the double is 25 euros.
- a certificate from a sports doctor about admission to participate in competitions.

AWARDING

The winners of the categories are awarded with unique cups, medals and diplomas. Prize-winners in all categories are awarded with medals and diplomas.

ACCORDING TO THE RESULTS OF ALL TYPES OF THE PROGRAM, THE TEAM CHAMPIONSHIP IS SUMMED UP AND THE WINNING TEAM IS AWARDED A SPECIAL CUP
